Attorney Jeffrey Dorrell of Hanszen Laporte has a very well documented "close and personal relationship" with Vexatious litigant and convicted felon Thomas Christopher Retzlaff (<http://www.txcourts.gov/judicial-data/vexatious-litigants/>). We sued Thomas Retzlaff and his partner in crime, fugitive Neal Rauhauser in 2014 for numerous claims, including business interference, business disparagement, personal defamation, etc. Inexplicably Judge Cosby from the 67th District in Fort Worth Texas awarded fugitive from the law Neal Rauhauser \$1.3 million in fees and sanctions for a case that was non-suited, where the defendant was never served, and on contingency. Judge Cosby reduced the award to \$450,000 which is currently on appeal.

During our case, Attorney Jeffrey Dorrell has gone on record numerous times stating that Thomas Retzlaff is a "lunatic" and that he has "no relationship with Thomas Retzlaff". (Reporter Record Case #067-270669-14).

On September 16th, 2016, within case #09-16-00299-CV, Attorney Jeffrey Dorrell of Hanszen Laporte submitted a notarized affidavit in which he stated,

"I have no business or other relationship with Thomas Retzlaff. I am not a business associate of Thomas Retzlaff. Thomas Retzlaff is not my agent for any purpose. I have never published content on any blog jointly with Thomas Retzlaff. Neither I nor any firm with which I have ever been associated has ever paid to, or received from, Thomas Retzlaff, any compensation. I have never worked with Thomas Retzlaff to accomplish any joint objective. I have never requested or directed Thomas Retzlaff to do or publish anything. If John Morgan had not sued Thomas Retzlaff in McGibney v. Retzlaff - a suit in which I defended my client Neal Rauhauser - I would never have heard of Retzlaff. Any statement to the contrary is categorically false, has no evidentiary support, and could never have had evidentiary support."

What Attorney Jeffrey Dorrell did not realize before he submitted that Affidavit was that Attorney John Morgan had issued a properly served subpoena upon GoDaddy in an effort to find out how Thomas Retzlaff was able to fraudulently seize domains that I own. Within the subpoena results, which can be found here (<http://www.bullyville.com/?page=articles&id=1079>) there is an email from Attorney Jeffrey Dorrell (email forward) instructing Thomas Retzlaff to proceed on his (and Hanszen

Laporte's behalf). The evidence couldn't be any clearer, Attorney Jeffrey Dorrell not only committed perjury, he proved beyond a shadow of a doubt the "very close and personal relationship" that exists between himself and convicted felon Thomas Retzlaff. We are more than willing to provide any documentation the State Bar of Texas may require.

Mr. Dorrell will state that I'm just angry about the largest sanctions judgment in Texas history and the largest anti-SLAPP judgment in US History being levied against myself, a former United States Marine, and my company. And in some respects, he is correct, which is exactly why we've appealed the ruling. However, that's not what makes me angry. When an officer of the court blatantly lies about his relationship with a court documented pedophile/rapist who is a convicted felon, that is what is disconcerting. Mr. Dorrell will try to distort this complaint by listing all of his accomplishments, including his recent win with the United States Supreme Court. Although impressive, that has nothing to do with the perjury that he committed within Case #09-16-00299-CV.

I am respectfully asking the Office of the Chief Disciplinary Counsel to review this very serious (and easily provable) allegation of Perjury committed by Attorney Jeffrey Dorrell of Hanszen Laporte.
