around 6pm Jason L. Van Dyke asked me to help him find his 10mm firearm. We were looking for his 10mm when we noticed his 9mm missing, as well. When we were unable to locate the firearms, he noticed his cammo backpack missing along with my camera backpack. From what I remember, inside Jason Van Dykes bag was leopard thermal, various animal callers. Inside Isaacs backpack (me) was a canon 17-35mm lens, 24-105mm, 50mm STM lens, 20,000 mhp battery, LED's for photography, 2, 64CFast cards. After we realized that the items were missing we headed to dinner around 6:15-6:30. Jason VD later dropped me off at a friends house. haven't heard him since 1:36am. Last time I saw my camera bag was between ~~10~~ sep 6-10, in the white 2014 t-250 pins Ranch
